## CASI's Hall of Fame Award Criteria & Procedure

The CASI Hall of fame has been established in order that we may showcase previous and current award recipients.

### Hall of Fame Criteria:

Nominations are reviewed by a Hall of Fame Awards Committee.

The final decision must be unanimous. In order to preserve the high degree of honour, there is no obligation to have a recipient in any given year or to have only one honoree.

All nominations will be kept for a period of 4 years, and will be reviewed annually. Nomination forms must be sent in by the nominating person. Guidelines are as follows:

- a. Length of time actively teaching snowboarding. Ten years is the minimum.
- b. Length of time in CASI. Fifteen years is the minimum.
- c. The member should be over 40 years of age.
- d. Leadership and/or volunteer positions held within snow sports, i.e., Ski School Director or CASI Board Member, TEC Committee Member
- e. Contribution to our industry [i.e., what impact did individual have on our industry?].
- f. Has the member shown dedication to the sport of snowboarding or competitive snowboarding?
- g. Does the member show devotion to the CASI and promotion of the organization?

### Procedure:

1. All nomination forms must be returned to the CASI Head Office on or before the 1st of April in each year.
2. Only completed Nomination Forms will be considered. Please contact the Office Administrator at [info@casi-acms.com](mailto:info@casi-acms.com) if you are having difficulty in completing a section of the form.
3. The deadline for receipt of Nomination Forms may be extended by the Hall of Fame committee, with approval from the Board, in exceptional circumstances only.
4. The Hall of Fame committee will make recommendations to the Board for the award.
5. The final decision as to the identity of the Hall of Fame recipient must not be disclosed to any person or organization until the information has been made public.
6. All members of the Hall of Fame committee shall execute a confidentiality form so as to preserve the integrity of the award.

7. Where a committee member is also the nominating member of a Hall of Fame candidate, he/she shall refrain from voting for the nominee.
8. Notification of an award will be the sole responsibility of the Chair of the Hall of Fame committee.
9. All members of the Hall of Fame Committee must commit to maintaining the integrity and the confidentiality of the process.
